



Dare to Pisco - Getaway

A cocktail competition from The Pisco People

To officially launch its products in Australia *The Pisco People* is running a '*Dare to Pisco – Getaway*' cocktail competition for professional bartenders, with the overall winner awarded an incredible trip to Peru , the land of pisco.

Below are the 2015 competition terms and conditions:

1. The use of “promoter” in this document refers to The Pisco People, Level 2 / 420 Collins St Melbourne VIC 3000.
2. The use of “contestant” means a bartender entering the 2015 *Dare to Pisco – Getaway* competition (“competition”).
3. These conditions of entry and any information the promoter has made available to the contestant regarding the promotion comprise the terms and conditions (“terms and conditions”) which govern the competition.
4. Entry (or purported entry) into the competition is deemed acceptance of the terms and conditions.
5. The competition closes on **Wednesday 23 December 2015** (6.00pm AEST) (“competition period”).

7. Entry is open to any Australian bartender who holds a current RSA certificate, and who is currently works in a bar at a registered liquor licensed venue stocking at least one SKU from The Pisco People.
8. This is a competition where the winning contestant is based on the decision of the competition judge Daniel Monk.
9. A finalist from each of five state categories will be invited to travel to Melbourne for the national final to be held at Flinders on the Mornington Peninsula, Victoria from **Sunday 31 January to Tuesday 2 February 2016**.
10. The cost of economy class airfares, accommodation, airport transfers and meals for any state finalists travelling to Melbourne will be included as part of the competition prize.
11. The five State finalist categories are defined as:
 - i. NSW and ACT
 - ii. VIC & TAS
 - iii. QLD
 - iv. SA & NT
 - v. WA.
12. The national bartender winner of the '*Dare to Pisco - Getaway*' competition will be announced by



the competition judge after the final challenge on **Tuesday 2 February 2016**.

13. The winner will receive a hosted trip to Lima, Peru with an estimated value of **\$6000**.
14. The prize includes economy class air travel, accommodation, airport transfers and meals. The winner itinerary will include 3 days in the city Lima during which the winner will have the opportunity to participate in a pisco masterclass as well as visit bars and restaurants. The second part of the trip will include a pisco 'bodega' tour in Ica Valley located in the south of Peru, as well as sightseeing trips to Nazca lines and Huacachina for sand surfing.
15. The value of the prize is based upon the recommended retail prices of the trip at the date of printing. The promoter accepts no responsibility for any variation in the value of the prize after that date. Prizes cannot be taken as cash.
12. All ancillary costs or accessories not expressly included in the prize are the responsibility of the winning contestant. These ancillary costs include but are not limited to overseas currency conversion fees, additional sight-seeing tours and activities, travel insurance (including medical insurance) plus meals or drinks at venues not specified as part of the winner's itinerary.

14. The winner of the competition must be available to travel to Peru for 7 days, commencing from **Monday 21 March 2016** which is the period of valid use for the air travel ticket.

16. The promoter reserves the rights to publish any cocktails entered into the competition.
17. The promoter will take photographs and video footage which will be used for social media, press and video promotions. These photographs, and the name of the competition entrant, may be used at the discretion of the promoter. All images published will be appropriate and respectful.
